



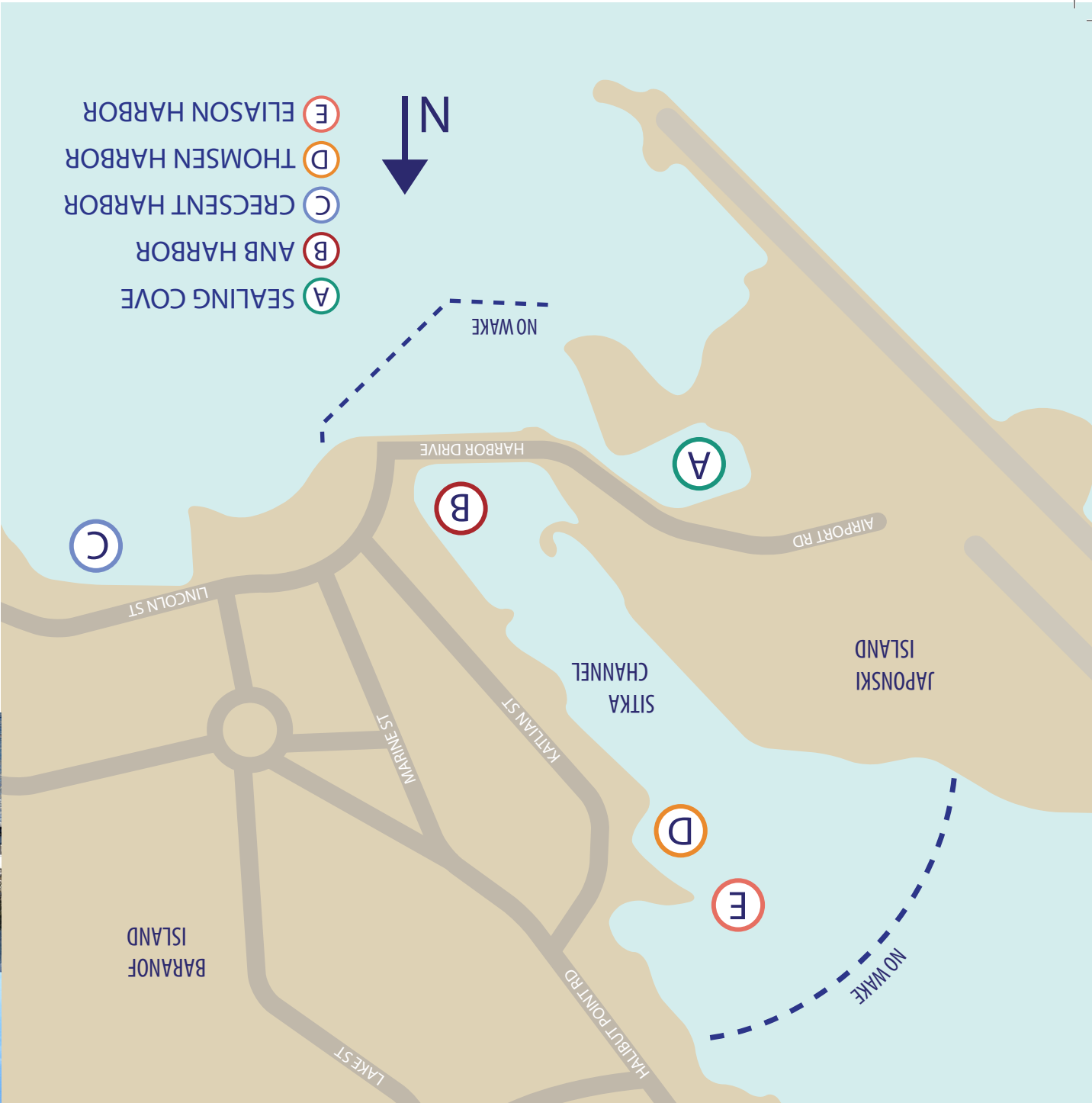

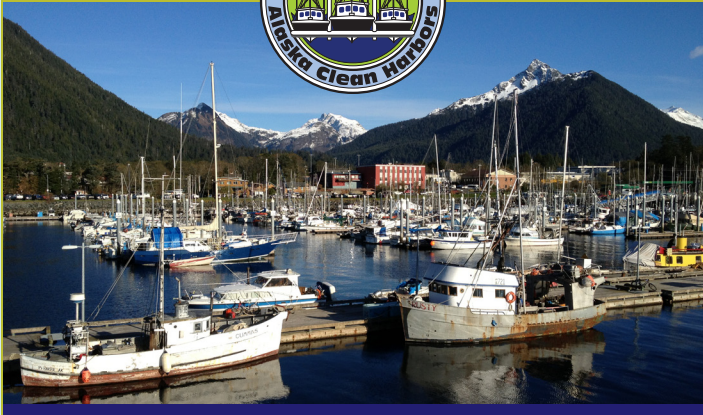

ARRIVING AT THE HARBOR

**No Wake Zones:** A "No Wake" speed is required in the harbor. "No Wake" speed is generally below 2.5 kts. No speeding allowed in the channel. Please respect the No Wake Zone shown on the local map.

**Registration of Transient Vessel Moorage:** Transient vessels are required to register with the Harbormaster within 8 hours of arrival. Information on services and fees is available at the Harbor office.

**Loading Zones:** There are several loading zones located throughout the harbors. They are easily identified by the white paint along the bull rails. Loading zones have a one-hour time limit.

**Used Oil:** Disposal tanks are provided at all harbors. Please do not dispose of gasoline or solvents in these tanks. When dumping used oil, please clean debris and old filters off the screen when you are finished.

**Water:** Potable Water is provided at all harbors year-round.

**Tidal Grid:** A steel and timber tidal grid is available for use next to ANB harbor. The grid is available on a first-come

first-served basis. Vessels are limited to 96 hours on the grid. Larger vessels (over 58 gross tons) must notify the harbormaster before using the grid.

**Fish Cleaning:** The cleaning of fish in any of Sitka's harbors is strictly forbidden. Fish cleaning should be done at designated fish cleaning tables. There are fish cleaning tables on the south end of Eliason Harbor breakwater and the float outside Sealing Cove harbor. Fish waste bins are available at both cleaning stations.

BASIC RULES AND PRACTICES

**A Sheen Is A Spill** Dispersants (soaps) are not only illegal, but deadly for marine life! Report all oil spills to 1-800-424-8802 and the Harbormaster's Office. Yellow drums on the floats contain spill response equipment and are not garbage cans. All harbor officers are trained in spill response.

**Hazardous Materials** Paint, paint chips, and grinding dust are hazardous and must be contained. These kinds of materials entering the harbor and waterways constitutes pollution and is prohibited throughout the harbors. Ask the Harbormaster for information on hazardous waste disposal.

**No Discharge Zone!** The discharge of any sewage (treated or untreated) into the harbor is prohibited. Please use the upland restroom facilities as much as possible during your stay in the Sitka Harbor system

**Scoop the Poop!** There are bag stations located throughout the harbors.

**Boat Washing** When you are washing your boat in the harbor, use cleaning products that are safe for the environment. The Harbormaster's office has information available for tenants on boat washing practices.

**Conserve Fresh Water!** We all must do our part to turn off hoses when not in use, report excessively leaking connectors on the docks, and curb usage to a minimal or only when necessary.

AMENITIES AND SERVICES

**110v, 220v, and 208v Single/Three Phase Electricity**

**Recycling of used oil, filters, oily rags, troll wire, zincs, and used batteries**

**Dumpsters throughout the harbors**

**Recycling of cardboard, aluminum, glass, plastic**

**Waste Pump Outs:**

The Harbor Department provides three pump outs throughout the system. Crescent Harbor, Thomsen Harbor and Eliason Harbor.

**Kids Don't Float** Children's PDFs are available at the top of every ramp in the harbor. State law requires all children under 13 to wear PDFs. Please return them at the end of your voyage!

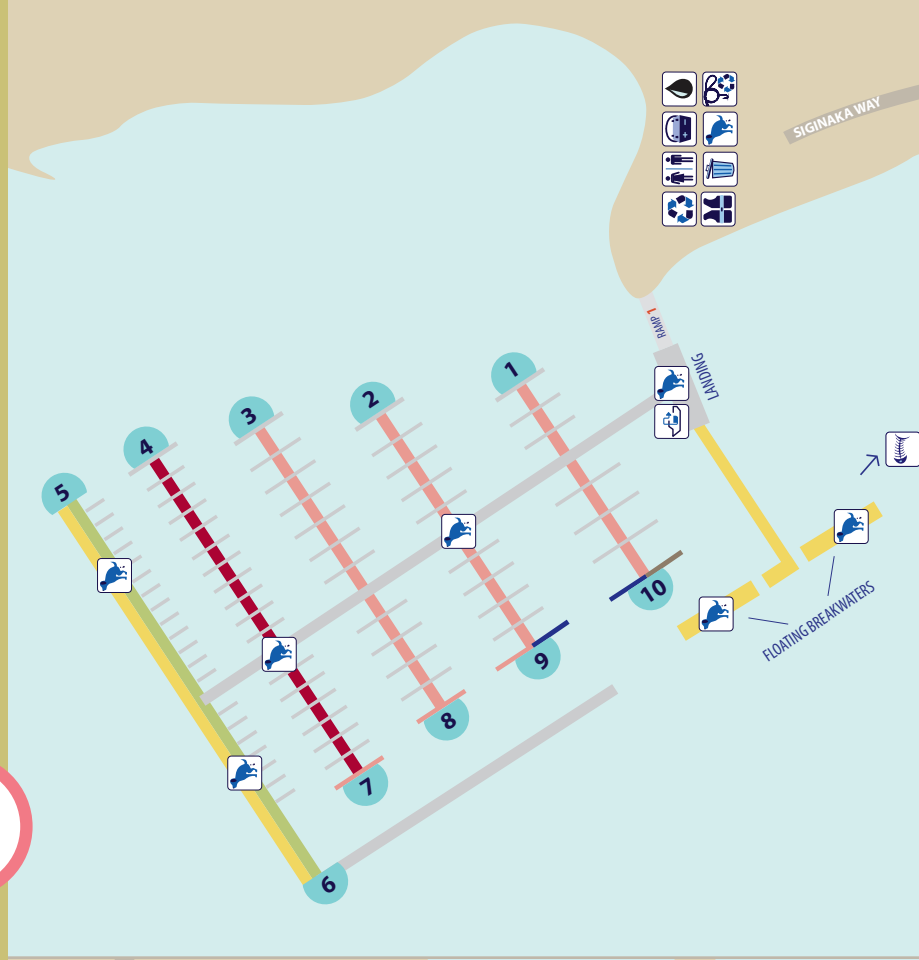
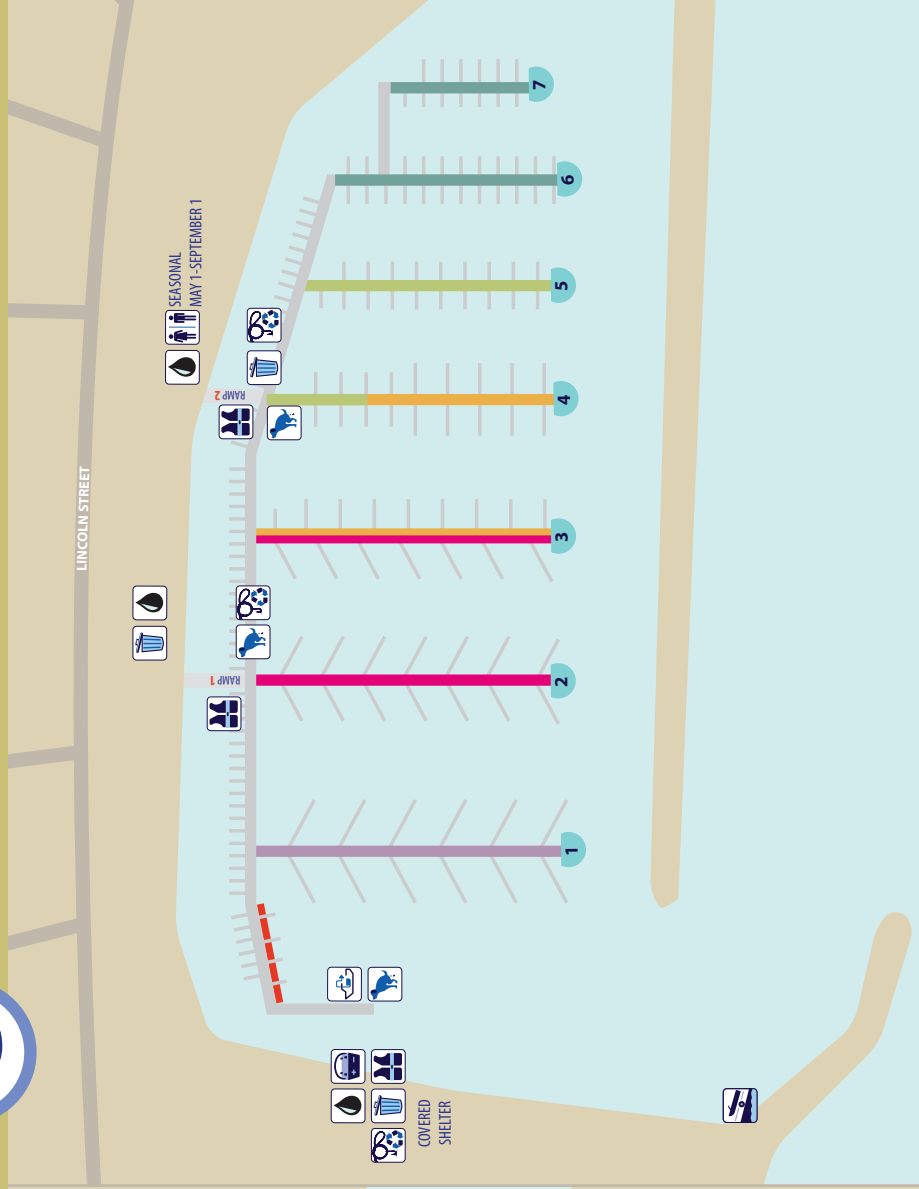
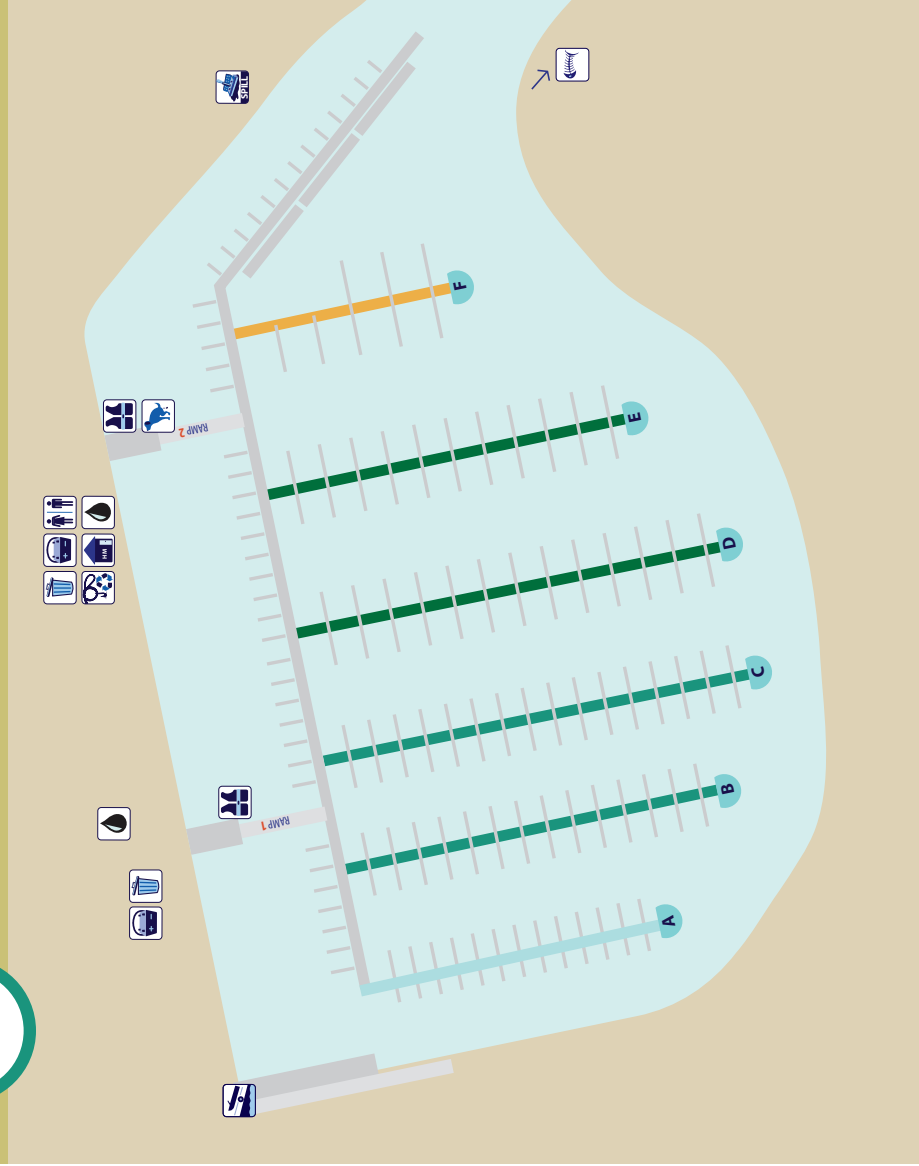
